### 4. SHARING OF FACILITIES



**WHERE AS,** MRCP is engaged in the business of providing quality pharmacy education for B.Pharm, M.Pharm and Pharm.D students.


**WHERE AS,** Malla Reddy Hospital is in the business of providing primary, secondary and tertiary care for patients and fully equipped and staffed to deal with medical emergencies.

**THEREFORE,** in consideration of mutual promises and other valuable information exchanged and intended to be legally bound, the parties hereby agree and contract as follows;

#### **GENERAL TERMS AND CONDITIONS**

1. **Background :** MRCP is an educational institution and is conducting B.Pharm, M.Pharm and Pharm.D courses with necessary approval by AICTE and Govt. of Telangana. The college is affiliated to Osmania University. Through this MOU, Malla Reddy Hospital will depute necessary Doctors and Nurses for conducting medical check-up of the students and staff in every six months.
2. **Admission :** Malla Reddy Hospital will admit and initiate appropriate treatment to the students and staff without delay. Any paper work related to admission and billing will be done as lower priority after the immediate emergency is controlled.
3. **Logistics :** Malla Reddy Hospital will provide an ambulance with a driver at the facility of MRCP whenever necessary.
4. **Billing :** Bills will be paid by the MRCP and not by the students and staff. Students and staff will be discharged with appropriate discharge summary sheets when the treatment is over. All bills pertaining to services will be presented by Malla Reddy Hospital to MRCP. Such bills will be settled within 30 days of producing invoice
5. **Validity :** This non-exclusive agreement is valid for ten years from the date of agreement and can be extended by mutual agreement. However, either party may terminate this agreement by giving two months notice in writing after settling all dues to other party.
